

Webbrok Internet Marketing and/or Jibspot Privacy Policy

June 01, 2009

At Jibspot we recognize that privacy is important. This Policy applies to all of the products, services and websites offered by Webbrok Internet Marketing and/or Jibspot or its subsidiaries or affiliated companies (collectively known as "services"). Webbrok Internet Marketing and/or Jibspot adheres to the privacy principles of applicable to its various spheres of operation and embodies Choice, Onward Transfer, Security, Data Integrity, Access and Enforcement.

Information we collect and how we use it:

We offer a number of services that do not require you to register for an account or provide any personal information to us, such as property searches. In order to provide our full range of services, we may collect the following types of information:

- **Information you provide** - When you sign up for a Webbrok Internet Marketing and/or Jibspot newsletter or other Webbrok Internet Marketing and/or Jibspot service or promotion that requires registration, we ask you for personal information (such as your name, email address and an account password). We may combine the information you submit under your account with information from other Webbrok Internet Marketing and/or Jibspot services or third parties in order to provide you with a better experience and to improve the quality of our services. For certain services, we may give you the opportunity to opt out of combining such information.
- **Webbrok Internet Marketing and/or Jibspot cookies** - When you visit a Webbrok Internet Marketing and/or Jibspot site, we send one or more cookies - a small file containing a string of characters - to your computer that uniquely identifies your browser. We use cookies to improve the quality of our service by storing user preferences and tracking user trends, such as how people search. Most browsers are initially set up to accept cookies, but you can reset your browser to refuse all cookies or to indicate when a cookie is being sent. However, some Webbrok Internet Marketing and/or Jibspot features and services may not function properly if your cookies are disabled.
- **User communications** - When you send email or other communication to Webbrok Internet Marketing and/or Jibspot, we may retain those communications in order to process your inquiries, respond to your requests and improve our services.
- **Affiliated sites** - We offer some of our services in connection with other web sites. Personal information that you provide to those sites may be sent to Webbrok Internet Marketing and/or Jibspot in order to deliver the service. We process such information in accordance with this Policy. The affiliated sites may have different privacy practices and we encourage you to read their privacy policies.
- **Links** - Webbrok Internet Marketing and/or Jibspot may present links in a format that enables us to keep track of whether these links have been followed. We use this information to improve the quality of our services, customized content and advertising.
- **Other sites** - This Privacy Policy applies to web sites and services that are owned and operated by Webbrok Internet Marketing and/or Jibspot. We do not exercise control over other sites. These other sites may place their own cookies or other files on your computer, collect data or solicit personal information from you.

Webbrok Internet Marketing and/or Jibspot only processes personal information for the purposes described in the applicable Privacy Policy and/or privacy notice for specific services. In addition to the above, such purposes include:

- Providing our products and services to users, including the display of customized content and advertising;
- Auditing, research and analysis in order to maintain, protect and improve our services;
- Ensuring the technical functioning of our network; and
- Developing new services.

Webbrok Internet Marketing and/or Jibspot processes personal information on our servers. In some cases, we process personal information on a server outside your own country. We may process personal information to provide our own services. In some cases, we may process personal information on behalf of and according to the instructions of a third party, such as our advertising partners.

Choices for personal information

When you sign up for a particular service that requires registration, we ask you to provide personal information. If we use this information in a manner different than the purpose for which it was collected, then we will ask for your consent prior to such use. You can decline to submit personal information to any of our services, in which case Webbrok Internet Marketing and/or Jibspot may not be able to provide those services to you.

Information sharing

Webbrok Internet Marketing and/or Jibspot only shares personal information with other companies or individuals outside of Webbrok Internet Marketing and/or Jibspot in the following limited circumstances:

- We have your consent. We require opt-in consent for the sharing of any sensitive personal information.
- We provide such information to our subsidiaries, affiliated companies or other trusted businesses or persons for the purpose of processing personal information on our behalf. We require that these parties agree to process such information based on our instructions and in compliance with this Policy and any other appropriate confidentiality and security measures.
- We have a good faith belief that access, use, preservation or disclosure of such information is reasonably necessary to (a) satisfy any applicable law, regulation, legal process or enforceable governmental request, (b) enforce applicable Terms of Service, including investigation of potential violations thereof, (c) detect, prevent, or otherwise address fraud, security or technical issues, or (d) protect against imminent harm to the rights, property or safety of Webbrok Internet Marketing and/or Jibspot, its users or the public as required or permitted by law.

If Webbrok Internet Marketing and/or Jibspot becomes involved in a merger, acquisition, or any form of sale of some or all of its assets, we will provide notice before personal information is transferred and becomes subject to a different privacy policy.

Information security

We take appropriate security measures to protect against unauthorized access to or unauthorized alteration, disclosure or destruction of data. These include internal reviews of our data collection, storage and processing practices and security measures, as well as physical security measures to guard against unauthorized access to systems where we store personal data.

We restrict access to personal information to Webbrok Internet Marketing and/or Jibspot employees, contractors and agents who need to know that information in order to operate, develop or improve our services. These individuals are bound by confidentiality obligations and may be subject to discipline, including termination and criminal prosecution, if they fail to meet these obligations.

Data integrity

Webbrok Internet Marketing and/or Jibspot processes personal information only for the purposes for which it was collected and in accordance with this Policy or any applicable service-specific privacy notice. We review our data collection, storage and processing practices to ensure that we only collect, store and process the personal information needed to provide or improve our services. We take reasonable steps to ensure that the personal information we process is accurate, complete, and current, but we depend on our users to update or correct their personal information whenever necessary.

Enforcement

Webbrok Internet Marketing and/or Jibspot regularly reviews its compliance with this Policy. When we receive formal written complaints at this address, it is Webbrok Internet Marketing and/or Jibspot policy to contact the complaining user regarding his or her concerns. We will cooperate with the appropriate regulatory authorities, including local data protection authorities, to resolve any complaints regarding the transfer of personal data that cannot be resolved between Webbrok Internet Marketing and/or Jibspot and an individual.

Please note that this Privacy Policy may change from time to time. We will not reduce your rights under this Policy without your explicit consent, and we expect most such changes will be minor. Regardless, we will post any Policy changes on this page and, if the changes are significant, we will provide a more prominent notice (including, for certain services, email notification of Policy changes).
